SUBJECT: A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ADOPTING THE 20TH AMENDMENT TO THE ANNUAL APPROPRIATIONS RESOLUTION NO. 2009-149 APPROPRIATING \$18,800 OF AMERICAN RECOVERY AND REINVESTMENT ACT GRANT FUNDS FROM THE FRESNO COUNTY WORKFORCE INVESTMENT BOARD FOR THE COORDINATION OF THE SUMMER YOUTH EMPLOYMENT PROGRAM ACTIVITIES ACROSS CITY DEPARTMENTS.

RECOMMENDATIONS

It is recommended that the City Council adopt the 20th Amendment to the Annual Appropriations Resolution (AAR) No. 2009-149.

EXECUTIVE SUMMARY

With the approval of this AAR, \$18,800 will be appropriated for a service provider agreement with the Fresno County Workforce Investment Board (FCWIB) to fund a Summer Youth Employment Program (SYEP) Community Coordinator within the City of Fresno.

BACKGROUND

Through the receipt of 2009 American Recovery and Reinvestment Act (AARA) funds, the FCWIB established a system of Summer Youth Employment Programs designed to prepare individuals for participation in the labor force by providing services that facilitate employment, increase earnings, enhance educational and occupational skills, facilitate self sufficiency, and decrease welfare dependency.

The City was selected by FCWIB on May 21, 2009, to coordinate the efforts of the service providers, Fresno County Economic Opportunities Commission (FCEOC) and Arbor, to provide this meaningful paid employment experience for the summer youth. On June 25, 2009, the City Council authorized the Planning and Development Department Interim Director to negotiate and enter into a service provider agreement with FCWIB. Therefore, this resolution will allow for the appropriation of that \$18,800.

The Personnel Services Department Community Coordinator provides high level coordination of the summer youth employment program activities across City departments. The Community Coordinator acts as a liaison between the City, FCWIB, FCEOC, and Arbor; providing access to job placement for summer youth at worksites across City departments and facilitates communication with City staff. The Community Coordinator tracks City of Fresno's summer youth and any issues worksite supervisors may have to ensure they are promptly addressed by the service providers.
