

**RECOMMENDATIONS**

Staff recommends that the City Council approve the attached resolution to accept and appropriate a \$500 grant received from the National Alliance for the Development of Archery to purchase supplies and training for After School Division.

**EXECUTIVE SUMMARY**

The Parks, After School, Recreation and Community Services Department (PARCS) was recently awarded a \$500 grant from the National Alliance for the Development of Archery to help fund the need for archery programs. The grant will allow PARCS to provide staff training as well as purchase bows, arrows, targets and other items needed to conduct archery instruction for youth who attend PARCS programs. The National Alliance for the Development of Archery provides grant funds that allows community agencies to receive instructed certification curriculum, training and equipment to develop archery programs. Additional recreational opportunities will enhance the quality of life for the youth in our community.

**KEY OBJECTIVE BALANCE**

The grant from the National Alliance for the Development of Archery would serve those individuals utilizing City programs as well as staff, thus improving customer and employee satisfaction within the community. The grant will assist PARCS efforts in providing a quality archery program by offsetting some of the supply costs such as, bows, arrows, and targets.

**BACKGROUND**

This year PARCS has provided archery instruction for approximately 150 kids who attended our Mayor's Friendship Camp and summer sports camps. A program survey completed by participants and staff indicated that participants desired more archery classes and that staff requested additional archery instruction. The grant will help PARCS improve staff instructional skills and provide additional services at neighborhood parks.

**FISCAL IMPACT**

Acceptance of this grant will have no impact to the General Fund.
