SUBJECT: CONSIDERATION OF TEXT AMENDMENT APPLICATION NO. TA-13-001 AND RELATED ENVIRONMENTAL FINDING FOR ENVIRONMENTAL ASSESSMENT NO. TA-13-001 RELATING TO TERMINATION OF RIGHTS FOR SPECIAL PERMITS

**RECOMMENDATION**

The appropriateness of the proposed text amendment has been examined pursuant to Section 12-402, and the Director has determined that the proposed text amendment is consistent with the goals and policies in the 2025 Fresno General Plan.

Upon consideration of staff evaluation, it can be concluded that proposed Text Amendment Application No. TA-13-001 is appropriate for the project area. Therefore, staff recommends the City Council take the following actions:

1. APPROVE to the City Council of the environmental finding of exemption from the California Environmental Quality Act (CEQA) pursuant to Section 15061 (b)(3) of the CEQA Guidelines which exempts projects that clearly will have no significant effect on the environment.
2. APPROVE to the City Council of Text Amendment Application No. TA-13-001.

**EXECUTIVE SUMMARY**

Text Amendment No. TA-13-001 proposes to amend Section 12-405-B-2 of the Fresno Municipal Code related to the termination of rights for special permits. Specifically, the text amendment would extend the rights granted by a conditional use permits that are discontinued from one to three years within specified areas.

Currently, when a particular use has been granted through a special permit (Site Plan Review or conditional use permit) and has become discontinued for a period of one year, all rights therein have been ceased. A proprietor wishing to have the same use would then be subject to a filing a new application and payment of all appropriate fees. Under the proposed text amendment, the termination of rights as a result of a vacant operation will be extended from one year to three years.

## **ENVIRONMENTAL FINDING**

The State Guidelines for the implementation of the California Environmental Quality Act provide for the exemption of projects which will clearly have no significant effects on the environment. More specifically, Section 15061(b) (3) of the State CEQA Guidelines states:

"...CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA."

It has been determined that there is no possibility of significant adverse effects as a result of this proposal.

## **PUBLIC NOTICE**

In accordance with Fresno Municipal Code Section 12-402-B, a notice of hearing was published in the Fresno Bee on January 25, 2013, 10 days prior to the planning commission hearing date. No comments have been received by staff.

## **BACKGROUND/ANALYSIS**

Text Amendment No. TA-13-001 proposes to amend Section 12-405-B-2 of the Fresno Municipal Code related to the termination of rights for special permits. Specifically, the text amendment would extend the rights granted by a conditional use permits that are discontinued from one to three years within specified areas. This proposal will limited to those areas located outside planning boundaries set forth by the Airport Land Use Commission (ALUC). The attached maps show the planning boundaries for the established airports within the City of Fresno.

Currently, when a particular use has been granted through a special permit (site plan review or conditional use permit) and has become discontinued for a period of one year, all rights therein have been ceased. A proprietor wishing to have the same use would then be subject to a filing a new application and payment of all appropriate fees. Under the proposed text amendment, the termination of rights as a result of a vacant operation will be extended from one year to three years for those areas outside the established planning boundaries of local airports.

The most common occurrence of expired special permits involve restaurants with alcohol related CUP's or used car lots. Staff has been aware of several instances where a vacant facility was fast approaching its one year deadline only to have prospective tenants be turned away due to financial constraints and timing. The extension from one to three years is viewed as an opportunity for potential investors to explore options plan accordingly and not be constrained to finite period.

## **PLANNING COMMISSION ACTION**

On February 6, 2012, the Fresno City Planning Commission considered this matter and after a full and complete hearing resolved to recommend approval of Text Amendment Application No. TA-13-001 by a vote of 6 to 0.

## **Conclusion**

Staff believes that the proposed text amendment is in the best interest of the City of Fresno. Staff supports Text amendment No. TA-11-001 as proposed in the attached Draft Ordinance.



## Exhibit A

SECTION 12-405-D TERMINATION OF RIGHTS. A special permit, and all rights granted therein, shall be considered terminated when either of the following occur:

1. Failure to commence the exercise of rights as required by Section 12-405-C.
2. Whenever the rights granted by a conditional use permit are discontinued for a continuous period of one year. [However, for conditional use permits granted outside the planning boundary established by the Airport Land Use Commission pursuant to California Public Utilities Code Section 21675, as may be amended, the conditional use permit shall be considered terminated whenever the rights granted by that permit are discontinued for a period of three years.]






AN ORDINANCE OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AMENDING SECTION 12-405-D-2 OF THE FRESNO MUNICIPAL CODE RELATING TO TERMINATION OF RIGHTS FOR SPECIAL PERMITS

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 12-205-D of the Fresno Municipal Code is amended to read:

SECTION 12-405-D TERMINATION OF RIGHTS. A special permit, and all rights granted therein, shall be considered terminated when either of the following occur:

1. Failure to commence the exercise of rights as required by Section 12-405-C.
2. Whenever the rights granted by a conditional use permit are discontinued for a continuous period of one year. [However, for conditional use permits granted outside the planning boundary established by the Airport Land Use Commission pursuant to California Public Utilities Code Section 21675, as may be amended, the conditional use permit shall be considered terminated whenever the rights granted by that permit are discontinued for a continuous period of three years.]

SECTION 2. This ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
