



RESOLUTION NO. 2009-192

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO,
CALIFORNIA AUTHORIZING A LOCALLY PREFERRED
ALTERNATIVE FOR BUS RAPID TRANSIT

WHEREAS, the City of Fresno/Fresno Area Express (FAX) has completed a Bus Rapid Transit (BRT) Master Plan (Kimley-Horn and Associates, November 2008); and

WHEREAS, the BRT Master Plan recommended FAX evaluate four corridors for the first phase of BRT improvements; and

WHEREAS, FAX conducted multiple public outreach events to review and receive input on the proposed corridors identified as: (1) Ventura/Kings Canyon from Fowler Avenue on the east to Downtown Fresno; (2) Blackstone Avenue from Manchester Transit Center on the north to Downtown Fresno; (3) Ventura/Kings Canyon from Fowler Avenue to Downtown Fresno, and then to Manchester Transit Center (a combination of the two above); and (4) Blackstone Avenue from the Market Place at River Park to Downtown Fresno; and

WHEREAS, the City of Fresno/FAX must present a Very Small Starts (VSS) report to the Federal Transit Administration (FTA) that declares a Locally Preferred Alternative (LPA) for the BRT to enter into project development.
