RESOLUTION SUPPORTING THE SHORT-TERM REGIONAL  
TRANSPORTATION PROGRAM LISTING OF PROJECTS  
AND THE SHORT-TERM REGIONAL TRANSPORTATION  
PROGRAM HANDBOOK

WHEREAS, in November 2006, the voters of Fresno County approved a 20 year-extension of Measure C including the Measure C Expenditure Plan; and

WHEREAS, the voter-approved Measure C Expenditure Plan specified certain urban and rural projects for which a percentage of the Measure C sales tax revenues could be used, further described in the Expenditure Plan as Tier 1 projects; and

WHEREAS, the Council of Fresno County Governments (COG) and Fresno County Transportation Authority (FCTA) have previously adopted detailed implementation programs and handbooks for street maintenance, transit, ADA, bike lanes, trails, flexible funding in order to release these funds to the agencies at the earliest possible date; and

WHEREAS, the Council recognizes the challenges faced by the COG and FCTA on the Regional Transportation Program, including implementation of the Measure C-mandated Regional Traffic Mitigation Fee (RTMF), scoping and budget issues on large and complex multi-phase regional projects, and programming of multiple funding sources such as Federal SAFETEA-LU, State Traffic Congestion Relief Program (TCRP), STIP, RTMF, and local development impact fees; and

WHEREAS, the City has participated in a technical Regional Steering Committee addressing RTMF implementation and the Short-term Regional Program; and

WHEREAS, representatives of the City of Fresno and the City of Clovis along with the COG and its consultant have reached consensus on a technical priority and the ability to deliver the local projects by year; and

WHEREAS, the proposed Short-Term Regional Program and the associated handbook have been approved by the regional steering committee, the COG Transportation Technical Committee (TTC), the COG Policy Advisory Committee (PAC), the COG Board and the FCTA Board to be released for a 45-day public comment and review period; and

WHEREAS, the City desires to proceed as expeditiously as possible to construct the projects as set forth in the Short-Term Regional Program; and

WHEREAS, the COG Board is scheduled to consider final approval of the Short-Term Regional Program on January 29, 2009, and the FCTA Board is scheduled to consider final approval of the Short-Term Regional Program on February 18, 2009.

NOW THEREFORE, let it be resolved that the Council of the City of Fresno does support the Short-Term Regional Program and Handbook as recommended by the COG and FCTA Boards.
