



RESOLUTION NO. 2009-198

A RESOLUTION OF CITY COUNCIL AUTHORIZING THE APPLICATION FOR AND ACCEPTANCE OF FY 2008 CYCLE OF U.S. DEPARTMENT OF HOMELAND SECURITY ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM FUNDING AND AUTHORIZING COMPLETION OF DOCUMENTS

WHEREAS, the U.S. Department of Homeland Security ("DHS") provides funding for the FY 2008 Cycle Assistance to Firefighters Grant Program ("Program") which is administered by DHS Federal Emergency Management Agency's ("FEMA") Grant Programs Directorate; and

WHEREAS, the Program requires that City must match the Federal grant funds with an amount of non-federal funds equal to 20 percent of the total project costs; and

WHEREAS, the applicant will enter into an agreement with FEMA for the grant funded Program.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO:

1. Approves the acceptance of grant funds for the U.S. Department of Homeland Security through FEMA for the FY 2008 Cycle Assistance to Firefighters Grant Program, contingent upon grant funds being available; and
2. Certifies, to the extent consistent with all Constitution and local law requirements and this resolution, that the City has or will have sufficient funds to operate and maintain the Program; and
3. Certifies that the City has reviewed, understands and, to the extent consistent with all Constitutional and local law requirements and this resolution, agrees to the provisions contained in the Application, Award and Program Guidelines; and
4. Appoints the Fire Chief for the City of Fresno, as agent of the City of Fresno, to conduct all negotiations and take any actions necessary for the purpose of obtaining the federal financial assistance hereunder, execute and submit documents including, but not limited to,
