



**A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, REGARDING THE OBJECTION TO LISTING THE FULTON MALL ON THE NATIONAL, STATE OR LOCAL HISTORIC REGISTER**

**WHEREAS,** the Fresno City Council has unanimously approved a contract for the development of the Fulton Corridor Specific Plan (FCSP) and Downtown Neighborhoods Community Plan (DNCP) for the revitalization of our downtown core and the neighborhoods that encircle our downtown; and

**WHEREAS,** the FCSP and DNCP will be community-led efforts to shape the future of our downtown and will consider issues such as the Fulton Mall, location of a High Speed Rail Station, form-based code, design guidelines, open space, mixed-use and residential development, traffic and infrastructure; and

**WHEREAS,** the Plans will provide for a survey of 300 buildings and possible identification of historic resources through our historic preservation sub-consultant; and

**WHEREAS,** the City of Fresno's Historic Preservation Commission, under the authority of our agreement as a Certified Local Government, have unanimously voted against including the Fulton Mall on the Historic Register at this time.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Fresno objects to the listing of the Fulton Mall on the National, State or Local Historic Register at this time. The Council calls on the State Historical Resources Commission to delay any action on this matter until the citizens of Fresno and the stakeholders in our downtown have the opportunity to consider all of the issues and options facing downtown Fresno through the thoughtful context of a community planning process.
