For and in consideration of permitting Players to observe and participate in activities, operations and/or functions given by the City of Fresno, in the City of Fresno, County of Fresno and State of California, beginning on \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, the Undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for personal injuries, property damage or wrongful death occurring to him/herself arising as a result of observing, participating, and/or engaging in activities, operations and/or functions or any incidental thereto wherever or however the same may occur and for whatever period said activities or instructions may continue, and the players do for him/herself, his/her heirs, executors, administrators hereby release, waive, discharge and relinquish any action or causes of actions, aforesaid, which may hereafter arise from him/herself and his/her state, and agrees that under no circumstances will he/she or his/her heirs, executors, administrators, and assigns prosecute, present any claim for personal injury, property damage or wrongful death against the City of Fresno or any of its officers, agents, servants, or employees for any of said causes of action whether the same shall arise by the negligence of any of said persons, or otherwise. IT IS THE INTENTION OF Players BY THIS INSTRUMENT, TO HAVE AGREED TO THE ASSUMPTION OF THE RISK AND, TO EXEMPT AND RELIEVE THE CITY OF FRESNO, INSTRUMENT, TO HAVE AGREED TO THE ASSUMPTION OF THE RISK AND, TO EXEMPT AND RELIEVE THE CITY OF FRESNO, OR ANY OF ITS OFFICERS, AGENTS, SERVANTS OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY PASSIVE OR ACTIVE NEGLIGENCE. The Players, for him/herself, his/her heirs, executors, administrators or assigns agrees that in the event any claim for personal injury, property damage or wrongful death shall be prosecuted against the City of Fresno, or any of its officers, agents, servants or employees, he/she shall indemnify and save harmless the same the City of Fresno, or any of its officers, agents, servants or employees from any and all claims or causes of action by whomever or whoever made or presented for personal injuries, property damage or wrongful death.
