WHEREAS, the spread of COVID-19 has rapidly decreased, to the point it no longer presents an imminent threat to public health and safety; and

WHEREAS, the Mayor proclaimed the termination of the local emergency on June 10, 2022; and

WHEREAS, pursuant to Fresno Municipal Code Section 5-203, the Council hereby confirms the termination of the local emergency.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council hereby confirms the Mayor's June 10, 2022, Proclamation of Termination of Local Emergency Related to COVID-19.


