- Current Signing and Striping General Notes (available at <https://www.fresno.gov/publicworks/developer-doorway>)

Show on plans:

- Call out of all new signing with reference to the California Manual on Uniform Traffic Control Devices (latest edition).
- Call out of all existing signs to be removed, to remain or be relocated.
- Install D3-2 signs and G8-22 signs for all super (SD) arterials and expressways.
- Install oversize street name signs per City STD. P-90 on safety lights or signal poles.
- All signs are to be installed by the owner's/developer's contractor and shall be shown on the signing and striping plan.
- Install temporary timber-barricades per P-100 with N-1(CA) or N-2(CA) markers where applicable.
- All striping including centerlines, lane lines, channelizing line, two-way left turn lanes edge line, bike lanes, etc.; include lane width and linear feet and/or stationing for length.
- All striping located and dimensioned relative to face of curb or other existing features.
- Lane widths: center-to-center or face of curb to center of stripe.
- Limits and lengths of transitions, tapers, lane width variations, etc.
- Proper transitions to existing striping that will remain.
- Call out of all striping that is to be removed or remain; include lane width and linear feet and/or stationing for length.
- Install cross-walk(s) per City STD. E-24 where applicable.
- Slurry seal where applicable per City Specification 28-3.
