Purpose of the Office of Independent Review

The Office of Independent Review (OIR) is responsible for ensuring that complaints about the conduct of the Fresno Police Department (FPD) are thoroughly investigated to enhance community trust. The OIR monitors ongoing investigations conducted by the FPD Internal Affairs (IA) unit and, when completed performs a comprehensive audit of the process. Each audit report will focus on evaluating the adequacy, thoroughness, quality and accuracy of the investigative report. The OIR assists in strengthening the relationship between the community and the police department by promoting greater transparency and collaboration.

The OIR is independent from the FPD allowing it to work as a conduit in the community. The OIR also meets regularly with members from local groups to listen to the public's interest and perspective.

The OIR is scheduled to release four quarterly reports per year to increase transparency, public awareness and understanding.

Purpose of the Report

The objective of the OIR, in preparing this report is that the constituents of the City of Fresno see transparency by all parties involved in the review of complaints.

The following report is intended to show a detailed summary of all complaints submitted to the FPD during the first quarter of 2014. The OIR does not conduct its own investigation but is given full access, monitors and contributes to the existing IA investigation. Once IA has completed its investigation the file is submitted to the OIR for audit.

The first quarter report reflects all complaints made to the IA Unit of the FPD, along with the recommendations made by the OIR between the dates of 01/01/14 - 03/31/14. The report is reflective of complaints that are handled within the ICF system, as well as those more serious allegations which are immediately assigned within the IA Pro system. Some complaints begin as ICFs and once that investigation is concluded, mutate to become full IA investigations. As the charts within this report reflect, some cases are still pending with the IA Unit and will be audited upon completion of IA's own examination of those cases. Also, within this report are separate charts that list reports that have been listed as pending in previous OIR quarterly reports. These charts will detail if the cases have since been audited or continue in a pending status.

Additionally, recommendations are always communicated to the FPD within the audit, regarding the case specific incident that generated the recommendation. Other, broader recommendations and/or "trends" are also communicated to the FPD as they are identified weeks prior to the OIR Quarterly Report being published this is an effort to ensure that the FPD is aware of issues and is able to react, address or consider each item, and is done so in the most time effective manner possible. The FPD has been extremely responsive to these notifications and has offered clarifying information or language, prior to the reports being published.

Definitions

Unfounded: The reported incident did not occur.

Exonerated: The employee's actions were reasonable under the circumstances.

Not Sustained: There is insufficient evidence to support a conclusion as to whether or not the employee violated policy.

Sustained: The employee's action(s) are in violation of the policy or procedure of the Police department.

Trends/Issues Identified and Relayed to the Police Department

The OIR recommends that the FPD Firearms Training sessions re-emphasize that officers conduct a thorough check and maintain awareness of the "back drop" or background prior to firing their weapon.

SUBJECT: IA CASE CLOSING LETTERS

The Fresno P. D. Internal Affairs Bureau received your inquiry on the Department's practice of notifying citizen complainants within thirty days of completion of the investigation of their allegations of misconduct. We reviewed all of our completed internal affairs cases from the beginning of 2010 through March 31, 2014. For that period we handled 306 cases. Of those, in 300 cases, we have a copy of the letter sent to the complainant notifying them the investigation into their complaint had been completed and the findings of the investigation. Each of those letters had been sent within thirty days of completing the case. In one case, the letter was sent, but past the thirty day mark. Finally, we identified five cases where we cannot confirm that the letter was sent. While the letters were possibly sent, we cannot prove that as we do not have a copy of the letter in the file.

Due to the transitory nature of some citizens who complain, we cannot always confirm receipt of the letter. In other cases, citizens move and do not provide us with their updated address. As a result, there may be some instances where the complainant did not receive the letter we sent them. Recognizing this, we will now incorporate into the file any returned letters we receive that are marked as undeliverable.

We also keep citizens regularly updated as to the status of their complaint by sending them a letter every thirty days while the investigation is in progress. Citizens may call the Internal Affairs Bureau to check on the status of their complaint and need not wait to receive a letter.

The department's policy regarding the sending of these letters is as follows:

CLOSING AND Thirty (30) Day Letters

IA Senior Secretary types letters to complainants every 30 days until the IA investigation is completed.

Once the investigation is completed, the IA secretary will send a letter to the citizen complainant notifying them of the completion of the investigation and the findings of the misconduct alleged by the complainant. This letter is to be sent within 30 days of the completion of an IA investigation.
