Purpose of the Office of Independent Review

The Office of Independent Review (OIR) is responsible for ensuring that complaints about the conduct of the Fresno Police Department (FPD) are thoroughly investigated to enhance community trust. The OIR monitors ongoing investigations conducted by the FPD Internal Affairs (IA) unit and, when completed performs a comprehensive audit of the process. Each audit report will focus on evaluating the adequacy, thoroughness, quality and accuracy of the investigative report. The OIR assists in strengthening the relationship between the community and the police department by promoting greater transparency and collaboration.

The OIR is independent from the FPD allowing it to work as a conduit in the community. The OIR also meets regularly with members from local groups to listen to the public's interest and perspective.

The OIR is scheduled to release four quarterly reports per year to increase transparency, public awareness and understanding.

Purpose of the Report

The objective of the OIR, in preparing this report is that the constituents of the City of Fresno see transparency by all parties involved in the review of complaints.

The following report is intended to show a detailed summary of all complaints submitted to the FPD during the third quarter of 2014. The OIR does not conduct its own investigation but is given full access, monitors and contributes to the existing IA investigation. Once IA has completed its investigation the file is submitted to the OIR for audit.

The third quarter report reflects all complaints made to the IA Unit of the FPD, along with the recommendations made by the OIR between the dates of 06/27/2014 - 09/30/14. The report is reflective of complaints that are handled within the ICF system, as well as those more serious allegations which are immediately assigned within the IA Pro system. Some complaints begin as ICFs and once that investigation is concluded, mutate to become full IA investigations. As the charts within this report reflect, some cases are still pending with the IA Unit and will be audited upon completion of IA's own examination of those cases. Also, within this report are separate charts that list reports that have been listed as pending in previous OIR quarterly reports. These charts will detail if the cases have since been audited or continue in a pending status.

Additionally, recommendations are always communicated to the FPD within the audit, regarding the case specific incident that generated the recommendation. Other, broader recommendations and/or "trends" are also communicated to the FPD as they are identified weeks prior to the OIR Quarterly Report being published this is an effort to ensure that the FPD is aware of issues and is able to react, address or consider each item, and is done so in the most time effective manner possible. The FPD has been extremely responsive to these notifications and has offered clarifying information or language, prior to the reports being published.

Definitions

Unfounded: The reported incident did not occur.

Exonerated: The employee's actions were reasonable under the circumstances.

Not Sustained: There is insufficient evidence to support a conclusion as to whether or not the employee violated policy.

Sustained: The employee's action(s) are in violation of the policy or procedure of the Police department.

Trends/Issues Identified and Relayed to the Police Department

OIR encourages the FPD to promote to officers their use of "officer discretion" when making a decision to tow a vehicle. In cases reviewed, the FPD always followed the law and towed vehicles when the driver was illegally operating the vehicle, for multiple reasons. However, there may be situations wherein family members are present and the vehicle can lawfully be turned over to them rather than having it towed. Again, OIR recognizes that there may be investigative reasons, or the driver may be a repeat offender, wherein turning the vehicle may not serve the overall public's best interest. But, if no aggravating circumstances exist, not towing the vehicle will save a great deal of money for the family and will show that officers used discretion in such a way as to bring closer together the police and the public.

OIR reviewed a single case wherein the officer had with him an "on-body" camera. In the matter, two allegations were put forth by the citizen and the videotape provided by the officer absolutely proved that no unreasonable force was used during the encounter. In fact, the recording demonstrated that the complainant's version did not occur in any manner he described. Therefore, his second allegation, which lacked evidence from either point of view, was viewed in light of his inaccurate first complaint. OIR cannot stress how helpful officer worn cameras are in figuring out the actual events in any complaint. Additionally, antidotal data coming in from around the nation tends to support that when officers are wearing video cameras, conduct by officers and citizens alike is much improved and complaints decrease. But in any case, when a video recording is made, sorting out the submitted complaints becomes incredibly easier. OIR speculates that the expense of equipping all officers with video cameras is likely to be offset by the decreased costs associated with investigating allegations due to a marked decrease in such complaints combined with the costs incurred by defending allegations in court.
