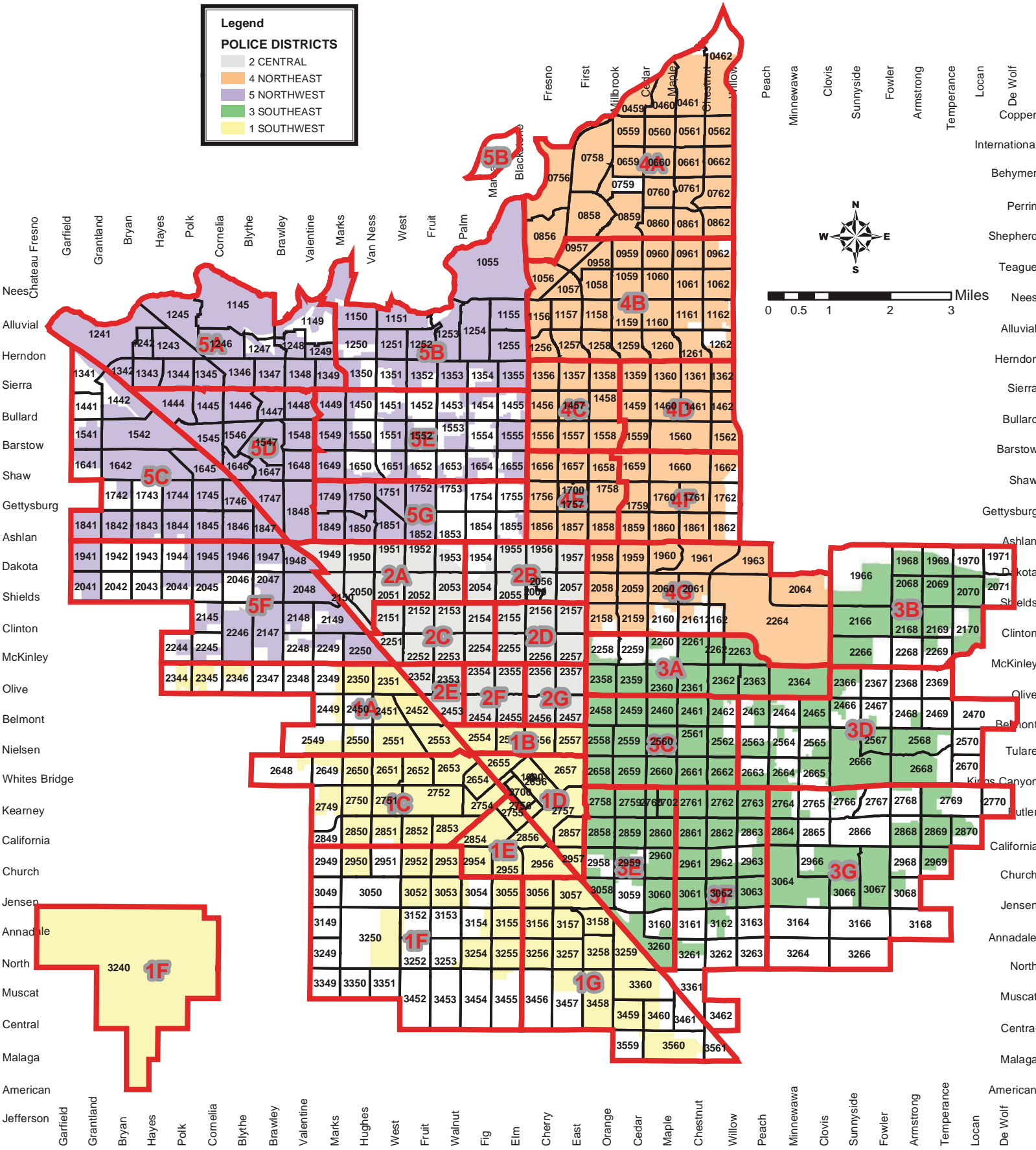

In December 1999, a new CAD/RMS system was brought in which did not accurately capture DER larceny counts, resulting in a lower than normal larceny count. - [14] FPD reorganization: CVU was established on January 15, 2007 under Sergeant Tom Rowe.
- [15] Jan - Jun 2007 e-Reports (larcenies) were all added to July's counts.
- [16] FPD district boundaries were revised & implemented on January 1, 2009.
- [17] Due to software conversion, arson counts were added to the Index Total initiating the numbers for years 2005-2008. Adjustments were made to correct sub-totals.
- [18] FPD district boundaries were revised & implemented on January 1, 2011, going from five districts to four.
- [19] Due to transition from paper copy report to automated reports 2 Justifiable Homicide count were under reported for the year of 2010 and 2011. Adjustments were made in house but FBI counts will remain the same.
