- SUBJECT: 2017 DEMOGRAPHIC DATA ANALYSIS

The 2017 Demographic Data Collection (DDC) report has been produced and reviewed. The DDC information contained in the report is generated by an automated program maintained by Information Services Bureau personnel. It contains a combination of traffic stop data from the Crossroads program (utilized by the Traffic Bureau) and Data 911(DDC forms completed on in-car computer).

Of the 59,009 traffic stops recorded by the DDC program during 2017, 58,951 electronic DDC collection forms were submitted correctly. A review of CAD records for events with the opening class of "3C" revealed there were 56,704 traffic stops during 2017. The difference between CAD and DDC traffic stop numbers is due to the method by which the DDC program collects DDC data. One example would be when one officer uses one disposition of a "3C" for each traffic stops they make and a motor officer might use one disposition of "3C" for multiple traffic stops, such as a DUI check point.

The demographic breakdown of the City of Fresno is as follows:

- Hispanic 46.9%;
- White 30.0%;
- Black 7.7%;
- Asian 12.3%; and
- Other 3.1%.

2017 Demographic Analysis

The percentage of subjects stopped by race is as follows;

- Hispanic 48.5%;
- White 24.4%;
- Black 13.9%;
- Asian 5.2%; and
- Other 8.1%.

The majority of traffic stops were made in the Northeast District (27%), followed by the Central District (20.9%), Southeast District (19%), Southwest District (18.9%) and Northwest District (14.1%). The most frequent reason cited for traffic stops was hazardous moving violations (62%), followed by non-hazardous moving violations (17.7%) and vehicle equipment violations (15.2%). Less than 1% of the traffic stops are for Daily Crime Bulletin (DCB) entries.

DCB suspects are generally identified by victims or witnesses to the crime involved, or other investigative means such as video. The demographics for DCB wanted subjects were as follows;

- Hispanic 52%;
- Black 27.5%;
- White 16.8%;
- Asian 2.4%;
- Other 0.8%; and
- Unknown 0.5%

Approximately 9.2% of traffic stops resulted in the vehicle being searched by officers.

After comparing Fresno's demographic breakdown of traffic stops per district and reason for the traffic stop, it appears there are no trends that are out of the normal range at this time.

The data reflected in the current DDC report should be reviewed to determine what modifications, if any, should be made to the program to enhance its effectiveness. Currently, Traffic Section and Patrol Division traffic stop data is combined and cannot be differentiated when reviewing the report.





TOTAL TRAFFIC STOPS YEAR 2017 - 59,009









TRAFFIC STOPS BY HOUR OF THE DAY CITY-WIDE


