SUBJECT: STUDENT AND NEIGHBORHOOD RESOURCE OFFICERS SPRING  
2017 STUDENT CONTACT ANALYSIS

This Student Contact Analysis (SCA) report provides an analysis of documented student contacts at the 14 Fresno Unified School District (FUSD) middle schools where Student and Neighborhood Resource Officers (SNRO's) are staffed. The SNRO unit is supported by a three-year federal Community Oriented Policing Services (COPS) grant and a partnership between the Fresno Police Department and the Fresno Unified School District. The unit has officers assigned to Ahwahnee, Baird, Computech, Cooper Academy, Gaston, Kings Canyon, Scandinavian, Sequoia, Tehipite, Tenaya, Terronez, Tioga, Wawona, and Tehipite Middle Schools.

SNRO's work to ensure the safety of the students and school personnel on their campuses. They investigate incidents that occur at the schools, assist with mediation to prevent criminal violations, and mentor the students. They also work in the neighborhoods around the middle schools and elementary schools that feed into their assigned middle schools. They address crime in the neighborhoods and quality of life issues that put our school-aged youth at risk. SNRO's actively participate in school events and community events in the neighborhoods.

SCA reports are published quarterly. This SCA report covers the reporting period for April through June 2017. The SCA data contained in this analysis is generated by reporting mechanisms required of SNRO's and maintained by the sergeant assigned to the SNRO unit. Citation and arrest data is also maintained automatically in the Department's Report Writer Systems under each officer's identification.

The demographic breakdown of the City of Fresno used for Demographic Data Analysis, as reported in the US Census Bureau's most recent published information, is as follows:

- Hispanic 46.9%,
- American Indian / Alaskan Native 1.7%,
- Asian 12.6%,
- Black / African American 8.3%,
- Hawaiian / Pacific Islander 0.2%, and
- White 30.0%.

2017 Student Contact Analysis

As provided at the beginning of the school year, the total student population in Fresno Unified School District's middle schools at all campuses where SNRO's are assigned is 9,875. Demographic information and student populations were provided by each school site and represent a point in time analysis for January 2017.

The demographic breakdown of the schools where SNRO's are assigned is as follows:

- Hispanic 68.1%,
- American Indian / Alaskan Native 0.5%,
- Asian 10.2%,
- Black / African American 8.3%,
- Hawaiian / Pacific Islander 0.4%,
- White 10.5%, and
- Multiple 2.1%.

A review of the SCA for this reporting period established that there were a total of 92 reported crimes. Of the reported crimes, three were felonies, 81 were misdemeanors, and 8 were infractions reported for 9,875 students on the 14 campuses where SNRO's are assigned. This represents 0.93% of the student population (92 of 9,875 students) were involved in reported criminal activity during this period of analysis.

Of the 92 reported crimes, three juveniles were booked into the Fresno County Juvenile Justice Campus. Additionally, 49 students who were contacted by SNRO's for being involved in low-level, non-violent criminal behavior were either reprimanded or released or were involved in restorative practices or peer mediation practices involving school staff. This equates to 53.26% of all crime-related contacts made by SNRO's during this reporting period being diverted from the Juvenile Justice System through alternative resolutions and effective use of restorative practice techniques.

The demographic data of the 92 youth committing reported crimes during this analysis period is as follows:

- Hispanic 65.22%,
- Black 19.57%,
- White 8.7%, and
- Asian 6.52%.

The demographic data of the 49 youth who were reprimanded and released or involved in restorative practices, including peer mediation and Youth Court, is as follows:

- Hispanic 65.31%,
- Black 18.37%,
- White 8.16%, and
- Asian 8.16%.

Of the 92 reported crimes that occurred for this analysis period on school campuses where SNRO's are assigned, the following crimes were reported most often:

- 17 violations of Penal Code 415 – fighting (18.48% of all reported crimes),
- 15 violations of Penal Code 484 – theft (16.3% of all reported crimes),
- 14 violations of Penal Code section 243.2 – battery on school grounds (15.22% of all reported crimes), and
- 12 violations of Penal Code 242 – battery (14.13% of all reported crimes).

The data reflected in the current SCA report will be reviewed and then compared to the next SCA report to determine what modifications, if any, should be made to the Student and Neighborhood Resource Officer Unit to enhance its effectiveness.

SUBJECT: STUDENT RESOURCE OFFICERS SPRING 2017 STUDENT CONTACT  
ANALYSIS

This Student Contact Analysis (SCA) report provides an analysis of documented student contacts at the 18 campuses where the Fresno Police Department staffs Student Resource Officers (SRO's). These campuses include high schools and continuation schools in the Fresno Unified School District (FUSD), Central Unified School District (CUSD), and Fresno County Office of Education District (FCOE) and middle schools in FUSD and CUSD. SRO's are currently assigned to Edison, Fresno, McLane, Roosevelt, Sunnyside, Hoover, Bullard, Cambridge, DeWolf, and Central East High Schools; Fort Miller, Phoenix Secondary Academy, Glacier Point, El Capitan, and Rio Vista Middle Schools; and Violet Hines Education Academy, Pathway, and Pershing Continuation Schools.

SCA reports are published quarterly. This SCA report covers the reporting period for April through June 2017. The SCA data contained in this analysis is generated by reporting mechanisms required of SRO's and maintained by the sergeant assigned to the SRO unit. Citation and arrest data is also maintained automatically in the Department's Report Writer Systems under each officer's identification.

The total student population is 22,296 school age youth in all campuses where SRO's are assigned for this quarter. Demographic information and student populations were provided by each school site and represent a point in time analysis for January 2017.

The demographic breakdown of the City of Fresno used for Demographic Data Analysis, as reported in the US Census Bureau's most recent published information, is as follows:

- Hispanic 46.9%,
- American Indian / Alaskan Native 1.7%,
- Asian 12.6%,
- Black / African American 8.3%,
- Hawaiian / Pacific Islander 0.2%, and
- White 30.0%.

The demographic breakdown of the schools where SRO's are assigned is as follows:

- Hispanic 62.20%,
- White 11.98%,
- Black 10.71%,
- Asian 13.21%,
- Hawaiian/Pacific Islander 0.28%,
- American Indian/Alaskan Native 0.59%,
- Multiple 0.96%, and
- Other 0.01%.

A review of the SCA for this reporting period showed there were a total of 199 reported crimes. Of the reported crimes, six were felonies, 171 were misdemeanors, and 22 were infractions reported for 22,926 students on the 18 campuses where SRO's are assigned. This represents 0.87% of the student population (199 of 22,926 students) were involved in reported criminal activity during this period of analysis.

Of the 199 reported crimes, 23 juveniles were booked into the Fresno County Juvenile Justice Campus. Additionally, 59 students who were contacted by SRO's for being involved in low-level, non-violent criminal behavior were either reprimanded or released or were involved in restorative practices or peer mediation practices involving school staff. This equates to 26.63% of all crime-related contacts made by SRO's during this reporting period being diverted from the Juvenile Justice System through alternative resolutions and effective use of restorative practice techniques.

The demographic data of the 199 youth committing reported crimes during this analysis period is as follows:

- Hispanic 63.32%,
- White 7.54%,
- Black 26.63%,
- Asian 1.51%, and
- Missing 1%.

The demographic data of the 59 youth who were reprimanded and released or involved in restorative practices, including peer mediation and Youth Court, is as follows:

- Hispanic 59.32%,
- White 5.08%,
- Black 28.81 %,
- Asian 3.38%, and
- Missing 3.38%.

Of the 199 reported crimes that occurred for this analysis period on school campuses where SRO's are assigned, the following crimes were most often reported:

- 67 violations of Penal Code 415, disturbing the peace (33.66% of all reported crimes),
- 30 violations of Penal Code 242/243, assault & battery (15.07% of all reported crimes), and
- 23 violations of Health & Safety Code 11357, possession of marijuana (11.55% of all reported crimes).

The data reflected in the current SCA report will be reviewed and then compared to the next SCA report to determine what modifications, if any, should be made to the Student Resource Officer unit to enhance its effectiveness.
