The yield earned on the Portfolio was 1.09 percent for the month ended February 2017. It was 1.00 percent for the month ended February 2016: a net increase of nine basis points, or 9 percent. The interest earned year to date has increased by \$457,396; or 14.15 percent. Mostly this increase is due to the portfolio earning higher yields, which can be seen in the increase in the rolling year to date yield. The size of the Portfolio increased by \$5,858,341. The Market Value of the Portfolio increased by \$3,096,094. The difference between \$5,858,341 and \$3,096,094 is \$2,762,247, which represents a decrease in the Market Value in relation to the Amortized Cost.

The Treasury Notes decreased by \$4,996,822, the Local Agency Fund decreased by \$24,745,998, and Time Deposits decreased by \$2,794,295. These resources, combined with the overall increase in the Portfolio of \$5,858,341 resulted in a total of \$33,122,949 in available resources to be reinvested. Of these funds, \$13,791,786 was invested in Federal Agency Notes, \$3,000,000 was invested in the Money Market, and \$21,603,670 was invested in Corporate Notes. An increase in interest rates is the cause for the decrease in the Market Value in relation to the Amortized Cost.

In accordance with State Law, the Finance Director certifies that the securities held in the City Investment Portfolio, purchased with Surplus Funds, comply with City policies. The Finance Director further certifies that the City has Operating Funds available to meet its expenditure requirements for the next six months.

Amortized Cost - the total amount at which investments are carried on the City books. This amount includes the amortization and accretion of premiums and discounts, respectively.

Market Value - the total amount at which investments are being sold in the market. Market prices are provided by the Bank of New York.

Maturity Value - (also referred to as "par value") the total amount of the face or stated value of the investments at maturity.

Average Days to Maturity - the average time in days left in the maturity of the investments.

Monthly Yield - the rate of return on investments as expressed in a percentage.

Rolling 12-Month Return - same Monthly yield, but for the past 12 months.

Earned Interest - the amount of income realized by all investments.


