



High-Efficiency Sprinkler Nozzle Rebate Program

REBATE SUMMARY

A rebate of **up to \$4.00 per qualified sprinkler nozzle** is available for the new installation or replacement of existing traditional overhead spray sprinklers with qualified high-efficiency sprinkler nozzles. Rebate requires a minimum of 6 nozzles. The maximum rebate is \$100.

High-efficiency sprinkler nozzles provide approximately 20% water savings compared to traditional pop-up sprinkler nozzles. High-efficiency sprinkler nozzles are compatible with most existing irrigation systems and are ideal for new irrigation systems. Instead of applying fixed streams of water with smaller droplets that are prone to drift in the wind, high-efficiency spray nozzles slowly deliver larger droplets of water, which reduces drift and runoff, and allows for more uniform soil absorption. High-efficiency sprinkler nozzles are ideal for slopes and clay soils, helping to reduce brown spots in these difficult-to-water areas.

Customers may request a free Water-Wise Landscape Consultation prior to purchasing high-efficiency sprinkler nozzles to help determine the compatibility of their existing irrigation system and learn more about the benefits of using high-efficiency sprinkler nozzles on their individual landscaping. Customers may request this service through the FresGO app or by calling the City of Fresno's 311 Center at (559) 621-CITY or by dialing 3-1-1 within City limits.

HIGH-EFFICIENCY SPRINKLER NOZZLE REBATE PROCESS

- 1. Obtain and complete an application.
- Purchase and install the qualifying high-efficiency sprinkler nozzles. A list of qualified nozzles
 is included in the High-Efficiency Sprinkler Nozzle Rebate Guidelines and Conditions.
 Applicants must install the high-efficiency sprinkler nozzles and submit rebate application
 within 90 days of purchase date.
- 3. Submit a completed application, along with a copy of the itemized, dated sales receipt(s) for the high-efficiency sprinkler nozzles within 90 days of purchase date, to:

- 4. A Water Conservation Landscape Specialist will arrange a brief appointment to inspect and verify the installation of the high-efficiency sprinkler nozzles.
- 5. Once final approval is granted, the rebate will be processed and a check will be mailed within 6-9 weeks of final approval.

HIGH-EFFICIENCY SPRINKLER NOZZLE REBATE PROGRAM GUIDELINES AND CONDITIONS

Qualifying Applicants

Residential, commercial, industrial, institutional, or multi-family customers who pay a water utility bill to the City of Fresno qualify to receive the High-Efficiency Sprinkler Nozzle Rebate. This rebate is also available to landlords of property serviced by the City of Fresno Water Division where the tenant is the water customer. Renters or tenants must provide written approval from the property owner or property manager for installation of high-efficiency sprinkler nozzles. New construction does not qualify.

Qualifying High-Efficiency Sprinkler Nozzles

Only newly-purchased high-efficiency sprinkler nozzles included in the list below qualify for this rebate. No other sprinkler nozzles will be included in the rebate.

- Hunter MP Rotators
- Rainbird R-VAN Series Rotary Nozzles
- Rainbird RN High Efficiency Rotary Nozzles
- Toro Precision Series Spray Nozzles (Including Pressure-Compensating version)
- Toro Precision Series Rotating Nozzles

Rebate Details

The rebate amount is up to \$4 per qualifying high-efficiency sprinkler nozzle. A minimum of 6 nozzles must be purchased. The maximum rebate is \$100. The rebate amount cannot be larger than the cost of the nozzles purchased. The rebate amount does not apply to labor or other costs. Accessories and taxes are also not included.

By submitting an application, applicants agree to an inspection to verify the installation of high-efficiency sprinkler nozzles. Rebates will only be awarded after verification of proper installation and compliance with the Requirements of this rebate. Rebate checks will be mailed 6-9 weeks after final approval.

Rebate Requirements

Site must have an efficient, well-maintained in-ground irrigation system compatible with high-efficiency sprinkler nozzles. All sprinklers controlled by a single sprinkler valve (station or zone) must be installed with the same model of high-efficiency sprinkler nozzle. The irrigation system and controller must be in good working order. High-efficiency sprinkler nozzles must be installed and rebate application submitted within 90 days of purchase date.

A copy of the original itemized, dated sales receipt for the new high-efficiency sprinkler nozzles must be submitted with the rebate application. Incomplete, incorrect, or unsigned applications cannot be processed and will be returned to the applicant. Applicants must fulfill all program guidelines to be eligible for a rebate.

- Possession or submission of a rebate application does not guarantee a rebate approval.
- Rebates are processed on a first-come, first-served basis.
