## **Forestry Frequently Asked Questions**

Q: Which trees are removed?

A: The City's goal is to maintain and grow our urban forest and for this reason trees are only removed by the City when dead, dying, diseased or deemed hazardous by a City Arborist.

Q: How do I request an inspection of a City tree near my property?

A: Call the One Call Center at (559) 621-2489 or by dialing 311 and create a FresGo ticket, it's important to provide your email address to receive timely updates or use the FresGo app to submit a request.

Q: I don't like or want the City tree in the City right of way or park-strip directly in front of my property, what can I do?

A: You can submit a request via the Forestry Request form. It is important to note that the City's goal is to protect, maintain and grow our urban forest. If you choose to proceed with a tree removal, and the City approves it you accept the responsibility and liability related to the removal of the tree. This includes hiring a licensed contractor and paying all related fees. The City does charge a fee of \$231.00 per tree for this, this fee is refundable once a new tree has been planted and inspection by the City. You can also contact Tree Fresno at (559) 221-5556 to request a free tree or purchase an approved tree at a local nursery.
