The proposal is for a mixed use project comprised of apartments, ground floor retail, ground-floor office/meeting rooms, and parking stalls to serve all uses, to be developed in phases.

Northwest Corner of Blackstone & Weldon Avenues – Robert Millford proposes a remodel of the Wendy's restaurant at 2005 N. Blackstone Ave. – no changes to drive-thru.
