The applicant proposes the construction of two fourplex multiple family two and three bedroom residential units; total building area is 8,922 square feet. The property is zoned R-2-A/cz (Low Density Multiple Family Residential, one story, conditions of zoning) "cz"; conditions of zoning limit development to a maximum of eight units on the site. The applicant is proposing eight units.

The property is zoned R-1-B (Single Family Residential, minimum 12,500 square-foot residential lot)
