





A savings account for local housing needs.





What is a Local Housing Trust Fund?


Main characteristics of a City Local Housing Trust Fund





Created by ordinance or resolution

Receives ongoing revenue from dedicated sources



Adopts Program Guidelines



2. State of CA LHTF Grant Program



State of California LHTF Grant Program

The State has announced \$57 million in matching funds available to new and existing LHTFs

 Up to \$5 million in matching funds is available per applicant*

The application period will open July 19th and close on August 3, 2021



*minimum is \$500k

Construction & Rehab


- Affordable rental and ownership housing
- Emergency Shelters
- Permanent Supportive Housing
- Transitional Housing
- Accessory Dwelling Units

Down-payment assistance



State of California LHTF Grant Program

Eligible Sources of Matching Funds



Ongoing and dedicated sources, such as taxes, fees, and loan repayments and/or public or private contributions.

A General Fund donation might be eligible, if the original source of the funds is eligible (i.e. sourced from taxes).




Alternatives

Alternative A – maximize competitiveness

Create two categories within the HTF.

- Category 1 is designed to maximize points for the Grant Application.
- Category 2 is established later with other funding sources for activities not included in Category 1.



Alternatives

Alternative A – Program Match (Category 1)

Activity/Project	AMI level	%
Affordable Rental Housing Development	≤ 60%	100

60% AMI for Fresno is \$42,420/yr for a household of four (4) or \$29,700/yr for a household of one (1).

Alternatives

Alternative B – maximize local priorities

All selected activities are Grant-eligible, but instead of maximizing application points, they are selected according to local need.

A second Category can still be created later to address needs that are not Grant-eligible.

Analysis of Impediments - Safety net programs; Improved housing conditions^{*}, Addressing racial disparities in homeownership; Access to areas of opportunity^{*}, Better communication; Addressing prejudices; and More education
