INTRODUCTION

The Americans with Disabilities Act (ADA) is a comprehensive civil rights law for persons with disabilities. Title II of the ADA provides that public entities must identify and evaluate all programs, activities, and services and review all policies, practices, and procedures that govern administration of the entity's programs, activities, and services. The Transition Plan lists, prioritizes, and sets forth a schedule for the physical changes that must be made in order to provide programmatic access to City of Fresno (City) programs, activities, and services.

The most recent ADA Facilities Transition Plan, adopted in September 2016, was prepared in partial fulfillment of the requirements set forth in Title II of the ADA. That report assists the City in identifying physical barriers to accessibility and in developing barrier removal solutions that will facilitate the opportunity of access to all individuals.

This addendum lists the budgeted facilities projects that are planned specifically for removal of barriers to program access as well as other facilities projects that include components that increase access to programs, services, and activities for members of the public. Due to the impacts of the COVID-19 global pandemic, the FY 21 addendum was prepared but not published; in some cases project completion dates were delayed as a result of COVID-19 impacts. This addendum covers both Fiscal Year 2021 (FY 21) and Fiscal Year 2022 (FY 22).

PURPOSE

The purpose of an annual addendum is multifaceted.

Foremost, it creates a dynamic process for adjustments to the Facilities Transition Plan as priorities and programs shift. This minimizes the potential for the Facilities Transition Plan to become inaccurate or outdated. It also provides an opportunity to reassess long range planning priorities as needs change or in response to grievances.

Secondly, it reflects the current budgeted work as well as the list of future planned improvements. This allows the City to quantify the monies allocated for facilities alterations and maintenance projects that impact accessibility. It further creates more streamlined tracking and documentation of efforts as well as an accurate documentation of current Facilities Transition Plan priorities schedule. This document will be made available to members of the public upon request.

Finally, it demonstrates a good faith effort for ongoing compliance. By sharing regular updates on progress and priorities with the public, the City creates the opportunity for dialogue with members of the public with disabilities and allays the perception of inaction.
