
One of our winners was Daniel Lorente. He was kind enough to write a thank you note, which he has permitted us to share. His story is below.

## Upcoming Public Outreach for the 2022 FAX Title VI Program Update and Proposed Service Changes

#### Come to FAX workshops to learn more about proposed service changes along Routes 3, 20, and 45, and our Title VI Program. We want to hear from you!

FAX is proposing a route extension on the western end of Route 45 to serve either Justin Garza High School or additional areas closer to Central High East, as well as frequency enhancements for three routes (Routes 3, 20, and 45). In addition, every three years, FAX updates its Title VI Program to make the public aware of their rights under Title VI, conduct an analysis of the demographic make-up of its service area, and detail the actions it has taken and/or will take to prevent discrimination.



#### **Proposed Service Changes**



#### What is Title VI?

The Civil Rights Act of 1964 prohibits discrimination based on race, color, or national origin by any program that receives funding from the Federal government. As a recipient of Federal funding, the City of Fresno (including both Fresno Area Express (FAX) and Handy Ride) is required to implement a Title VI Plan in order to ensure its transit and paratransit programs do not discriminate (intentionally or unintentionally) based on the color of a person's skin, race or ethnicity, or country of origin.

#### How does Title VI benefit FAX and its customers?

While FAX strives to be non-discriminatory under all circumstances, Title VI spells out specific actions that are considered discriminatory when they are based on an individual's race, color, or national origin. Some examples of prohibited actions include:

- Using race or English-language proficiency as criteria for eligibility for specific transit or paratransit programs.
- Not allowing someone who cannot speak English well to use FAX services because they cannot communicate in English.
- Not providing service information in a language that is spoken by a significant population within the service area.
- Assigning older buses or other equipment to predominately minority areas for chiefly demographic reasons.

#### Why should I be interested in the 2022 FAX Title VI Report?

Every three years, FAX prepares a Title VI report to make the public aware of their rights under Title VI, conduct an analysis of the demographic make-up of its service area, and detail the actions it has taken and/or will take to prevent discrimination. It also includes an equity analysis undertaken for fare changes, major service changes, and the construction of new transit facilities. A "Four-Factor Analysis" looks at the number and percentage of people who speak a particular language and do not speak English well, how frequently they interact with FAX, the importance of FAX's services to them, and the resources available to FAX to determine what language assistance measures are appropriate to address the needs of the community.

In March, FAX celebrated its 60<sup>th</sup> birthday with "FAX turns 60" events at Manchester Transit Center (MTC) and Courthouse Park. On March 9 and March 30, 2022, FAX staff was at MTC and Courthouse Park, providing riders with FAX goodies.

Additional activities took place during the month, including Fun Facts, and a video post highlighting riders, drivers, and supervisors on social media. While the celebration was for 60 years of FAX, we also celebrated you, our transit riders.

## Shaw-Cedar Bus Stop Improvement Project

Many of our transit riders use FAX as their main source of transportation. To better address the needs of our riders, FAX is upgrading passenger amenities and bus stops along heavily traveled corridors.

A total of sixty-three locations along Shaw Avenue (Route 9) and Cedar Avenue (Route 38) are receiving updated amenities, improved bus stop infrastructure, and are being made compliant with ADA requirements. These are high-frequency routes operating every 15 minutes during regular service hours. They also account for approximately 20% of the total ridership within the FAX fixed route system, with an average pre-pandemic monthly ridership of almost 200,000 per month and more than 2 million per year. Twenty-eight of these stops are on Shaw Avenue between Valentine and Cedar Avenues, and thirty-five of them are on Cedar Avenue between Shaw and Jensen Avenues.

The improvements will include bus layover pads at five locations, reinforced curbing where required, and incorporation of the recommendations from

the Bus Stop Facilities ADA Transition Plan. FAX expects this work to take place for nine months beginning in May 2022. The following rendering provides an image of the improvements.



This project will result in new shelters, benches, trash receptacles, and added security lighting. Ultimately, this project benefits 12 bus routes that intersect Routes 9 and 38, including Routes 1, 20, 22, 26, 28, 32, 34, 35, 38, 39, 41, and 45.

## **Federal Mask Mandate lifted for Public Transportation**

On April 18, 2022, a Federal judge lifted the mask mandate for public transportation. While FAX passengers and employees are no longer required to wear masks while on board our buses, masks are welcome and remain an important preventive measure against COVID-19. We encourage passengers to wear masks for their protection while riding FAX. In the meantime, we will continue to stock and issue masks to drivers and passengers upon request.

To protect the health and safety of FAX bus drivers and fellow transit riders, do not board the bus if you:

- Have a fever (100.4F), feel warm, or feel chills.
- Have a persistent cough, sore throat, or runny nose.
- Have had contact or spent time with a suspected or known COVID-19-infected individual.

If you meet any of these conditions, go home at once and self-isolate.
