

RESOLUTION NO. <u>2018-294</u>

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, SETTING CANNABIS BUSINESS LICENSE TAX RATES

WHEREAS, the voters of the City of Fresno approved the Cannabis Business License Tax Ordinance (the Ordinance) on November 6, 2018; and

WHEREAS, by its own terms, the Ordinance is effective ten days after the election results are certified by the City Council, and

WHEREAS, pursuant to Ordinance Section 7-1408, the taxes imposed by the Ordinance shall take effect no sooner than January 1, 2019, and only to the extent implemented by resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The following Cannabis Business License Tax rates are hereby set:
- a. <u>Cultivation</u>. For every person who is engaged in commercial cannabis cultivation in the City, \$6.00 annually per square foot of canopy space.
- b. Retailer, Testing Laboratory, Distribution, and Manufacturing. The following gross receipts rates shall apply to every person engaged in the operation of the indicated Cannabis-related business:
 - i. Retail Sales: 4% of gross receipts;
 - ii. Testing Laboratory: No gross receipts tax;
 - iii. Distribution: 1% of gross receipts; and
 - iv. Manufacturing: 4% of gross receipts.
