No Inner-City fee reduction will be applied to applications filed by government agencies or to any Alcoholic Beverage Conditional Use Permits (ABCUP) and Cannabis Conditional Use Permits.
- 3 No additional environmental review fees shall be charged, unless it is determined that a higher level of review than an exemption is required.
- 4 Fee listed includes the Moderate ZC fee plus the Level 1 Traffic Review Fee.
- 5 Fees are updated annually. For updated fees visit www.wildlife.ca.gov/Conservation/CEQA/Fees.
- 6 Fees are updated every July 1st based on CPI.

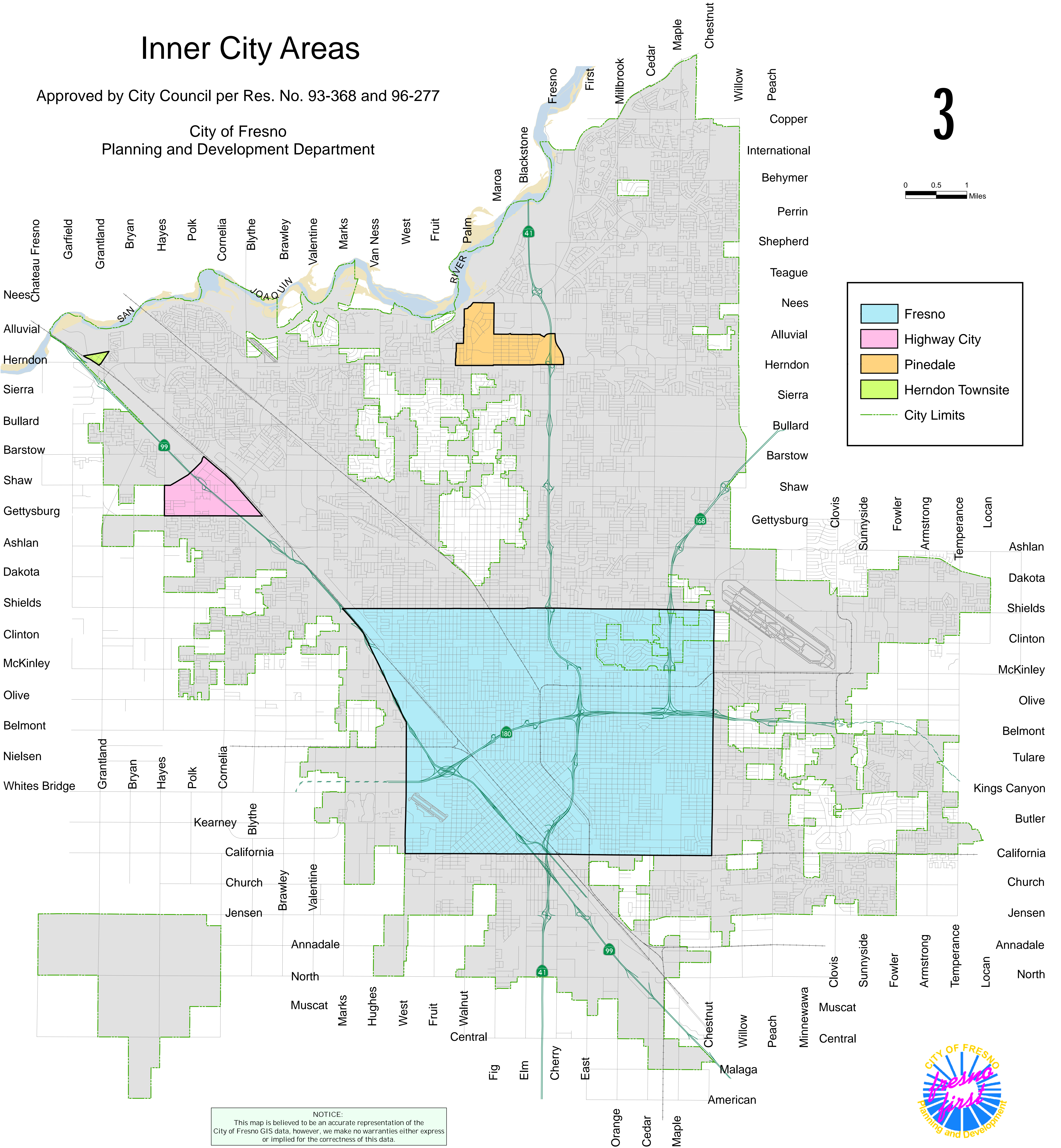
Inner City Areas
