On behalf of the City of Fresno (City) Stantec Consulting Services Inc. (Stantec) has prepared this letter to request your input regarding potential effects on threatened and endangered species associated with proposed abatement and demolition activities and a subsequent environmental site assessment (ESA) at the above-referenced property (Property). The Property is addressed as 735, 739, and 741 H Street (Assessor's Parcel Number 467-040-23) and contains a former office and industrial warehouse in downtown Fresno. The abatement and demolition is being funded through the City's US Environmental Protection Agency (EPA) Brownfields Revolving Loan Fund Grant (Cooperative Agreement # BF98T08001) and the assessment will be funded through the City's (EPA) Brownfields Coalition Assessment Grant (Cooperative Agreement # BF-99T91201-0).

Property Location, Description, and Development History

The initial warehouse on the Property was completed in 1906 for Madary's Lumber Yard, a lumber processing and distribution business in a centralized location in downtown Fresno, directly adjacent to the Southern Pacific Railroad tracks and freight yard and in an area of downtown that was dedicated to industrial development. The building was designed as a general warehouse and was utilized for a variety of industrial businesses, including lumber, plumbing, pesticides, produce, and other agricultural goods from 1906 to 2000. The building has been vacant since 2000 and the City reportedly took ownership of the Property in the early 2000's.

In August 2022, Stantec completed a Phase I environmental site assessment (ESA) for the Property. In December 2022, Stantec completed a Section 106 Inventory and Evaluation for the Property prior to abatement of hazardous building materials and demolition. This evaluation was conducted prior to abatement and demolition of the Property building and reaffirmed from previous evaluations that the Property and building were ineligible for listing on the National Register of Historic Places (NRHP) and that there were no adverse effects anticipated for the proposed project.

Proposed Abatement and Demolition

Regulated building materials will be abated from the property building in accordance with the Analysis of Brownfield Cleanup Alternatives (ABCA)² and the City-hired contractor's abatement and demolition workplan. The major scope elements of the abatement and demolition project will include:

- Abatement of asbestos containing materials, lead based paint, and other hazardous building materials as necessary;
- Demolition of the walls and floors of the building, and disposal/recycling of these materials;
- Removal of the concrete floor and basement slabs/walls and either on-site crushing and stockpiling of materials for future use, or off-site disposal at a concrete recycling facility;
- Removal and off-site disposal of the brick foundations; and,

Abatement and demolition activities will occur in 1Q23 (Fall of 2023) and will occur prior to proposed assessment activities described below.

Proposed Assessment

We plan to conduct a limited Phase II ESA to assess a recognized environmental condition identified during the Phase I ESA – namely the historic use of the portion of the building with historic addresses of 737-739 H Street ("Area C") by the building by California Spray Chemical Corporation from 1931-1947 as a pesticide storage and distribution warehouse. Due to the toxicity of these materials, there is potential for even minor releases (such as through cracks in the floor) to have resulted in significant releases to the environment through the basement floor. Environmental testing will be focused on this area of the building once it is demolished. The environmental sampling will consist of:

- Using 2-inch diameter borings across the Property to collect soil samples from soil underlying the floor of the building (once removed);
- Samples will be collected from depths approximately 10-15 feet below the ground surface;
 and,
- Samples will be analyzed for pesticides.

The proposed sampling will require approximately one week to complete. The scope of work is still being refined but will be provided in a Sampling and Analysis Plan (SAP) that is in preparation and which will be submitted to EPA for review and approval prior to performing the work.

Assessment activities are anticipated to occur in late 1Q23 or 2Q23 (Winter of 2023/2024).

Endangered Species Presence

A search was conducted on the US Fish and Wildlife Service (USFWS) Information, Planning, and Conservation (IPaC) system for threatened, endangered, and candidate species, and critical habitat on the Property. The IPaC system identified five (5) threatened or endangered species that may be present in the Property vicinity (Attachment A). These include the Fresno Kangaroo Rat, the San Joaquin Kit Fox, the Blunt-nosed Leopard Lizard, the California Tiger Salamander, and the Vernal Pool Fairy Shrimp. The IPaC system did not identify critical habitats on or near the Property. Based on the habitat requirements of the listed species, and the land use and development on and surrounding the Property, the species identified would not be expected to be present on the Property and the investigation scope described above is not anticipated to impact threatened and endangered (T&E) species, or non-T&E species.

Conclusions

Based on the habitat requirements of the listed species identified as potentially present in the Property vicinity, and the lack of critical habitat at the Property, the identified species is not be expected to be present at the Property. No affects to threatened, endangered, or candidate species or critical habitat is expected to occur from abatement, demolition and/or assessment activities.

Probability of Presence Summary

The graphs below provide our best understanding of when birds of concern are most likely to be present in your project area. Probability of Presence (■)

Each green bar represents the bird's relative probability of presence in the 10km grid cell(s) your project overlaps during a particular week of the year. (A year is represented as 12 4-week months.) A taller bar indicates a higher probability of species presence. The survey effort (see below) can be used to establish a level of confidence in the presence score. One can have higher confidence in the presence score if the corresponding survey effort is also high.

How is the probability of presence score calculated? The calculation is done in three steps:

- 1. The probability of presence for each week is calculated as the number of survey events in the week where the species was detected divided by the total number of survey events for that week. For example, if in week 12 there were 20 survey events and the Spotted Towhee was found in 5 of them, the probability of presence of the Spotted Towhee in week 12 is 0.25.
- 2. To properly present the pattern of presence across the year, the relative probability of presence is calculated. This is the probability of presence divided by the maximum probability of presence across all weeks. For example, imagine the probability of presence in week 20 for the Spotted Towhee is 0.05, and that the probability of presence at week 12 (0.25) is the maximum of any week of the year. The relative probability of presence on week 12 is 0.25/0.25 = 1; at week 20 it is 0.05/0.25 = 0.2.
- 3. The relative probability of presence calculated in the previous step undergoes a statistical conversion so that all possible values fall between 0 and 10, inclusive. This is the probability of presence score.

Breeding Season (=)

Yellow bars denote a very liberal estimate of the time-frame inside which the bird breeds across its entire range. If there are no yellow bars shown for a bird, it does not breed in your project area.

Survey Effort (I)



Survey Timeframe

Surveys from only the last 10 years are used in order to ensure delivery of currently relevant information. The exception to this is areas off the Atlantic coast, where bird returns are based on all years of available data, since data in these areas is currently much more sparse.

This location did not intersect any wetlands mapped by NWI.

NOTE: This initial screening does **not** replace an on-site delineation to determine whether wetlands occur. Additional information on the NWI data is provided below.

Data limitations

The Service's objective of mapping wetlands and deepwater habitats is to produce reconnaissance level information on the location, type and size of these resources. The maps are prepared from the analysis of high altitude imagery. Wetlands are identified based on vegetation, visible hydrology and geography. A margin of error is inherent in the use of imagery; thus, detailed on-the-ground inspection of any particular site may result in revision of the wetland boundaries or classification established through image analysis.

The accuracy of image interpretation depends on the quality of the imagery, the experience of the image analysts, the amount and quality of the collateral data and the amount of ground truth verification work conducted. Metadata should be consulted to determine the date of the source imagery used and any mapping problems.

Wetlands or other mapped features may have changed since the date of the imagery or field work. There may be occasional differences in polygon boundaries or classifications between the information depicted on the map and the actual conditions on site.

Data exclusions

Certain wetland habitats are excluded from the National mapping program because of the limitations of aerial imagery as the primary data source used to detect wetlands. These habitats include seagrasses or submerged aquatic vegetation that are found in the intertidal and subtidal zones of estuaries and nearshore coastal waters. Some deepwater reef communities (coral or tuberficid worm reefs) have also been excluded from the inventory. These habitats, because of their depth, go undetected by aerial imagery.

Data precautions

Federal, state, and local regulatory agencies with jurisdiction over wetlands may define and describe wetlands in a different manner than that used in this inventory. There is no attempt, in either the design or products of this inventory, to define the limits of proprietary jurisdiction of any Federal, state, or local government or to establish the geographical scope of the regulatory programs of government agencies. Persons intending to engage in activities involving modifications within or adjacent to wetland areas should seek the advice of appropriate Federal, state, or local agencies concerning specified agency regulatory programs and proprietary jurisdictions that may affect such activities.
