In its use of the Skybox, Designated User shall not discriminate on the basis of race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, marital status, sex, age, sexual orientation, ethnicity, status as a disabled veteran or veteran of the Vietnam era.
- 7. Designated User shall reasonably furnish to City such statements, records, reports, data, and information as City may request pertaining to use of the Skybox.
