Dear Residents' Committee Chairperson,

The enclosed information is your copy of the documents that were mailed to the mobilehome park owner. The CPI increase for all 2025 Rent Increase Applications is 1.7% as shown on the attached page titled Consumer Price Indexes Pacific Cities and U.S. City Average. The owner may automatically increase space rents by 75% of the CPI  $(0.75 \times 1.7\% = 1.3\%)$ . The dollar amount of the rent increase is based on the average rent of spaces affected by the Ordinance as of January 1st of that year.
