ORDINANCE NO. 2024-041

AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA,
AMENDING THE OFFICIAL LIST OF DESIGNATED SPECIAL
SPEED ZONES, PURSUANT TO SECTION 14-1501 OF THE
FRESNO MUNICIPAL CODE.

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:
