What is Homeless Housing, Assistance, and Prevention Funding?

Funding to continue efforts to end and prevent homelessness in our communities.



What is Homeless Housing, Assistance, and Prevention Funding?



HHAP 6 reflects the state's priorities to prevent and expeditiously reduce unsheltered homelessness.



The round 6 Notice of Funding Availability was released on February 24th and the application is due August 29th.



The jurisdictions within the FMCoC are working together to complete the application process and will submit one joint application.



The County, as the administrative entity for the FMCoC, will receive the CoC and County allocations in a single standard agreement.



Program Expectations


- Regional Collaboration and Strategic Partnerships

Eligible Activities


Eligible Activity categories are set by the State within the Notice of Funding Availability that was released on February 24, 2025

The FMCoC and partnering jurisdictions are seeking community input on what activities they see as most important to address and resolve homelessness.



Eligible Activities – Permanent Housing



Delivery of Permanent Housing and Innovative Housing Solutions.

Includes acquisition, development, improvement or renovation, maintenance of land or buildings, operating costs for programs such as Homekey, residential care facilities, and property tax abatements

Eligible Activities – Rapid Rehousing



Rapid Rehousing. Includes rental subsidies, move-in expenses, and landlord incentives, such as security deposits, holding fees, funding for needed repairs, and recruitment and relationship management costs.

Realojamiento Rápido. Incluye subvenciones de alquiler, gastos de mudanza e incentivos al arrendador, como depósitos de seguridad, tarifas de retención, financiación de reparaciones necesarias y costos de contratación y gestión de relaciones.

Eligible Activities – Prevention

Prevention and Shelter Diversion. Includes homelessness prevention through rental assistance, rapid rehousing, and other programs.

Eligible Activities – Interim Housing




Interim Housing Operating Subsidies and Improvements to Existing Interim Housing. Includes acquisition, improvement or renovation, and maintenance of land or buildings for interim housing, navigation centers, motel vouchers, service coordination, youth-focused services, capital funding to build new non-congregate interim housing sites, and subsidies that support ongoing operation and availability of existing interim housing – both congregate and non-congregate.

Subsidios para el funcionamiento de viviendas transitorias y mejoras de las viviendas transitorias existentes. Incluye la adquisición, mejora o renovación y mantenimiento de terrenos o edificios para viviendas transitorias, centros de navegación por la vivienda, cupones para moteles, coordinación de servicios, servicios centrados en los jóvenes, financiación de capital para construir nuevas viviendas transitorias no colectivas y subsidios que apoyen el funcionamiento y la disponibilidad de las viviendas transitorias existentes, tanto colectivas como no colectivas.

Eligible Activities – Service Coordination



Services and Service Coordination. Non-housing services for people experiencing unsheltered homelessness including people experiencing homelessness coming from encampment sites. Services are to be trauma-informed and practice harm reduction, including but not limited to:

- Street outreach support services
- Evidence-based engagement services
- Case management services
- Assertive community treatment
- Housing navigation
- Coordination with street-based health care services
- Hygiene services
- Access to workforce, education, and training programs

Other eligible services include costs and activities supporting people with lived experience necessary to create lived experience advisory boards, and youth advisory boards.

Eligible Activities – Service Coordination




Servicios y su coordinación. Servicios no relacionados con la vivienda para personas que están sin hogar y sin refugio, incluyendo aquellas que proceden de campamentos. Los servicios deben tener en cuenta los traumas y practicar la reducción de daños, lo que incluye, entre otros:

- Servicios de apoyo de divulgación en la calle
- Servicios de participación basados en pruebas
- Servicios de gestión de casos
- Tratamiento comunitario asertivo
- Búsqueda de vivienda
- Coordinación con los servicios de atención médica en la calle
- Servicios de higiene
- Acceso a programas de mano de obra, educación y capacitación

Otros servicios elegibles incluyen los costos y actividades de apoyo a las personas con experiencia vivida necesarios para crear consejos asesores de experiencia vivida, y consejos asesores de jóvenes.
