## Local Housing Trust Fund (LHTF)



*Goal:* To provide access to decent, safe, and affordable housing within the city for extremely low-, very low-, or low-income households earning below 60% of Area Median Income (AMI)

**Dedicated Funding Source:** A continuous revenue stream allocated to support affordable housing initiatives.

*City of Fresno LHTF:* Established in 2021 through Resolution 2021-201

### **Funded Projects**

#### **Cesar Chavez Apartments Project**

- Multifamily new construction of 54 affordable rental housing units (30% - 60% AMI)
- Developer responded to NOFA issued March 24, 2023
- City Council adopted a conditional funding commitment of \$5,000,000 in May 2024
- Located in Council District 5 on E. Cesar Chavez Blvd between 7<sup>th</sup> Street and 8<sup>th</sup> Street
