

PARK EQUIPMENT MECHANIC II

CLASS DEFINITION

Under supervision, repairs and services standard and specialized grounds maintenance and other non-automotive equipment.

SUPERVISION RECEIVED/EXERCISED

Receives supervision from a Manager or designee. Exercises no supervision.

DISTINGUISHING CHARACTERISTICS

Park Equipment Mechanic II is the journey level class in the Park Equipment Mechanic series. An incumbent overhauls engines used in ground maintenance and other non-automotive equipment. Repairs and services lawn mowers, edgers, sweepers, renovators, sod cutters, compressors, jack hammers, water pumps, cement mixers, weed and insecticide sprayers, and other standard and specialized non-automotive equipment and associated implements. This class is distinguished from the Park Equipment Mechanic Leadworker, in that the incumbents of the latter provides lead direction and participate in coordinating the maintenance and repair activities of the Park Equipment Shop.

EXAMPLES OF IMPORTANT AND ESSENTIAL DUTIES

May include, but are not limited to, the following:

Overhauls engines used in grounds maintenance and related non-automotive equipment.

Repairs and services lawn mowers, edgers, sweepers, renovators, sod cutters, compressors, jack hammers, water pumps, cement mixers, weed and herbicide sprayer systems, and other maintenance equipment and associated implements.

Performs field and shop inspections to determine the cause of mechanical failures and extent of necessary repair.

Inspects, removes, and replaces mower blades on mowing equipment.

Receives, unpacks, and stores parts and supplies in proper storage area.

Checks quality and quantity of items received against invoices, waybills and specification.

Orders parts and supplies for stock in accordance with prescribed procedures.

Performs related duties as required.

JOB RELATED AND ESSENTIAL QUALIFICATIONS

Knowledge of:

Methods, practices, materials, and tools of the automotive mechanic's trade.

Operation and repair characteristics of a variety of light gasoline powered machinery and equipment used in maintenance work.

Principles of internal combustion engines.

Hazards and safety requirements of the trade.

Elementary stock keeping principles and practices.

Skill/Ability to:

Understand and follow oral and written instructions.

Diagnose defects and mechanical failures in a wide variety of grounds maintenance and specialty type equipment.

Use and care for the tools and equipment of the mechanical trade.

Works in adverse weather conditions and exposure to hazardous materials and fumes.

MINIMUM QUALIFICATIONS

Education:

Possession of a High School Diploma or equivalent GED completion.

Experience:

Two (2) years of paid experience in the maintenance, service, and repair of small engines, grounds maintenance, landscape, or non-automotive equipment.

SPECIAL REQUIREMENT(S)

Possession of a valid Class C California Driver's License is required at the time of application and continued maintenance throughout the term of employment in the classification.

PHYSICAL DEMANDS

The physical demands described here are representative of those that are necessary to safely, effectively, and efficiently perform the essential functions of this job with or without

reasonable accommodation.

This classification's physical demands involve very heavy work which requires occasionally exerting in excess of 100 pounds of force occasionally with assistance, and/or in excess of 50 pounds of force frequently with assistance, and/or in excess of 20 pounds of force constantly to move objects. Additionally, the following physical demands may be required: balancing, climbing, crawling, crouching, feeling, manual dexterity, grasping, handling, hearing, kneeling, lifting, mental acuity, pulling, pushing, reaching, repetitive motion, speaking, standing, stooping, talking, visual acuity, walking.
