Some of the potential improvements we are interested in learning more about would be: Purchasing new multi-use furniture, or recliners or seating spaces that offer pull outs or extended areas or tables for placing personal items; Privacy solutions to help maximize the space for multiple users at a time, such as ceiling-mounted privacy curtains; We would like to explore installing maybe 3 "spaces" within the room, separating the spaces with privacy curtains or partitions, and providing each space with its own furniture (chair, small table, etc.) so the room can be used by up to 3 people at a time; Potential sink installation – adding a sink or set of sinks to a general use area of the room, if it is possible to gain access to a water source in that room; Installation of a fridge; Improved general storage or surface space (tables, cubbies, etc.) for personal items and pumping equipment – potentially small locker spaces to maintain privacy; Easier access to the space. Currently users must ask security to unlock the area for them. We would like to explore if a badge-in system would be more appropriate, especially if the space becomes multi-use.</p> <p>Our office would like to better understand what options are available to us so that we can begin developing a formal plan and understand what of the above upgrades we can realistically consider, depending on the limitations of the space and the administrative process.
