Measure P Overview

Measure P Grant Requirements

In addition to outlining requirements for the Cultural Arts Plan, the Measure P Ordinance (Sec. 7-1506(b)(4)) outlines the following grant program requirements:

(A) Twelve percent (12%) percent of the funds made available from Section 7-1504 shall be made available on an annual basis to invest in competitive grants for nonprofit organizations that support and expand access to arts and cultural programming.

(B) Grants funded pursuant to this paragraph shall:

- Be implemented by the Commission in partnership with the Fresno Arts Council, or its successor local arts agency.
- Use multiple solicitations that allow for a diverse set of programs, with different program sizes and reach.
- Include core operating and project-support grants.
- The Commission shall ensure that grant applications are reviewed in a transparent, competitive process.

(D) Funding for operating support distributed pursuant to this paragraph shall:

- Support organizational stability for arts and cultural organizations that reflect the cultural, geographic and demographic diversity of the City of Fresno; and
- Reflect the proportion of each grantee's overall operations that serve residents within, or visitors to, the City of Fresno sphere of influence.

(E) Grants funded pursuant to subparagraph (B) shall prioritize organizations and programs that support and expand diverse public or youth engagement and equity.

Measure P Funding Priorities

Measure P (Sec. 7-1506(b)(4)(E)) identifies the following funding priorities:

- Programs that support and expand diverse public engagement and equity
- Programs that support and expand youth engagement and equity

Cultural Arts Plan

- Vision: “Cultural Arts in Fresno will be recognized, prioritized, inclusive, accessible and continue to reflect, celebrate and connect the community.”
- Identifies goals, recommendations and strategies
- Required by Measure P
- Adopted August 2023 and updated every 5 years after



Available Funding

Funding Allocations

- Applicants can submit one application
- Fiscal sponsors may submit an application for themselves and on behalf of their fiscally sponsored organization(s)
- Two solicitations: Project Support and General Operating Support
- Will be awarded based on scores; between 75%-100% of request
- Partial awards <75% may be made if funding fully subscribed

Project Support

- 50% of funding in Cycle Three
- Minimum request: \$1,000
- Maximum request: \$75,000 to \$150,000
- Based on annual total revenue from most recent tax return
 - Form 990-N (e-Postcard) is sufficient if the organization had an annual revenue less than \$50,000.
- Immediate preceding tax year is accepted
- No tax return? Maximum request is \$75,000

General Operating Support

- 50% of funding in Cycle Three
- Minimum request: \$1,000
- Maximum request: \$50,000 to \$350,000
- Based on annual total revenue from most recent tax return; **proportionate share calculation & 20% ceiling**
 - Organizations with revenues of \$1,000,000 or more may apply for no more than 20% of their annual revenue as indicated on the organization's most recent 990
- Immediate preceding tax year is accepted
- No tax return? Maximum request is \$50,000

- Key Deadlines:
 - **August 15, 2026** – Eligibility Screening & Fiscal Sponsor Pre-qualification
 - **September 30, 2026** – Grant Application Due

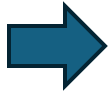
Eligibility Screening Criteria

- Be an active nonprofit charitable organization as described in section 501(c)3
- Support and expand access to arts and cultural programming
- Primary place of business is physically located within the City of Fresno limits
 - A P.O. box does not meet this requirement
- Serve City of Fresno residents or visitors
- Must have Cycle One reporting resolved/action plan submitted to be considered eligible for Cycle Three
- Be in “good standing” with:
 - IRS
 - CA Franchise Tax Board
 - CA Secretary of State
 - City of Fresno

Grant Overview

Project Support Grant Eligibility

Any active nonprofit charitable organization that:

1. Meets the definition of a charitable organization that is tax exempt under 26 USCA 501(c)(3) as described in section 501(c)3 of the Internal Revenue Code of 1986 (as amended), *AND*
2. Has **among its purposes**:
 - the provision of park, recreation or community services or facilities
 - art appreciation
 - trail development or management
 - gang prevention, intervention, and services for at-risk youth
 - conservation corps
 - environmental education and interpretation
 - or tree-planting

Project Support Grant Eligibility

How to demonstrate “**among its purposes**”:

- NTEE code(s) as designated by IRS
- Articles of Incorporation
- Bylaws
- Board adopted mission statement
- A resolution certified by the Secretary
- Another state or federal designation

General Operating Support Grant Eligibility

Any active nonprofit charitable organization that:

1. Meets the definition of a charitable organization that is tax exempt under 26 USCA 501(c)(3) as described in section 501(c)3 of the Internal Revenue Code of 1986 (as amended), *AND*
2. Applicants seeking funding for General Operating Support must be **an arts or cultural organization** (Section 7-1506(b) 4(D)).

General Operating Support Grant Eligibility

How to demonstrate “**arts or culture organization**”:

- NTEE code(s) as designated by IRS
- Articles of Incorporation
- Bylaws
- Board adopted mission statement
- A resolution certified by the Secretary
- Another state or federal designation

Check In!

- Is an organization *required* to have an NTEE code under the Arts, Culture & Humanities industry group?
 - *No... Organizations can also use their Articles of Incorporation, Bylaws, or Mission Statement to validate their eligibility.*

Ineligible Examples

Ineligible Applicants

- For-profit businesses or sole proprietorships
- Organizations that do not serve the public or provide public programming
- K-12 Schools; County Offices of Education; Public and Private Colleges and Universities
- Organizations whose primary mission is to raise funds
- Organizations whose primary mission is regranting
- Government agencies
- Any organization considered ineligible by Measure P (Fresno Municipal Code Chapter 7, Article 15, sections 7-1500 to 7-1519)

Ineligible Expense Examples

- Examples of ineligible expenses include:
 - Activities, programming, operations or events occurring outside of the City of Fresno's sphere of influence
 - Expenses that do not reasonably expand access to arts or culture. For example, purchases that are unrelated to the proposed scope of work, and do not demonstrate a clear tie to achieving the goals of the project
 - Alcohol or other controlled substances
 - Funds shall not be used to develop facilities on existing or former landfills or waste refuse facilities
 - Any expenses considered ineligible by Measure P (Fresno Municipal Code Chapter 7, Article 15, sections 7-1500 to 7-1519).

Ineligible Expense Examples

- *(Continued)* Examples of ineligible expenses include:
 - Cash prizes and scholarships
 - Political advocacy or lobbying
 - Fundraising
 - Projects with religious or evangelical purposes
 - Costs of goods for resale
 - **No costs shall be incurred prior to execution of the Grant Agreement**

Fiscal Sponsorship

Fiscal Sponsorship

- Measure P requires investment in **competitive grants for nonprofit organizations** that support and expand access to arts and cultural programming
- Fiscal sponsorship is a short-term solution intended to reduce barriers to accessing funding while emerging arts or cultural practitioners build capacity
- **Fiscal Sponsor Prequalification:** Any fiscal sponsor who submits **more than five (5) proposals** will be required to undergo a pre-qualification process to demonstrate sufficient internal controls
 - Includes completion of the City of Fresno's risk assessment which is included as Attachment A in Guidelines

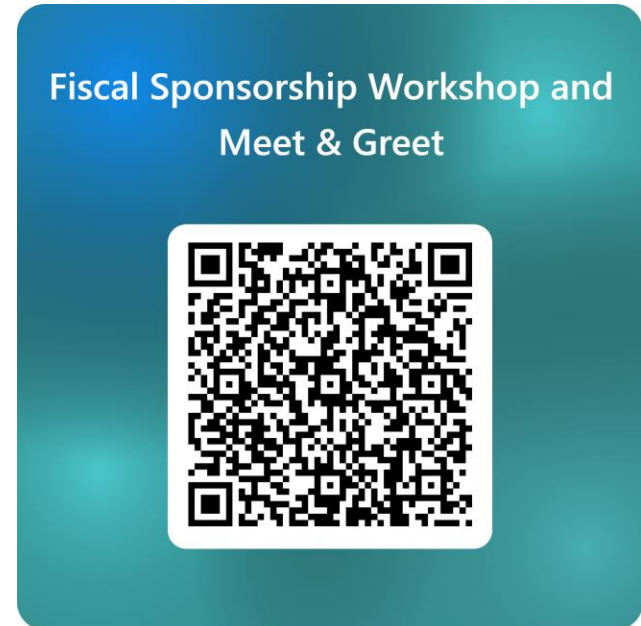

Application Process

Application Review & Scoring

- Representatives from diverse backgrounds
- Outreach efforts made to varied sources– social media, email notices, flyer distribution, etc.
- Handbook to guide scoring process transparently and competitively
- Training and compensation totaling \$500
- Conflict of interest disclosures required by all parties
- **PARCS staff are not members of the Application Review Committee (ARC)**
- **PRAC will review all ARC applications**

Fiscal Sponsorship

If using a fiscal sponsor, the eligibility screening and application **MUST** be completed by the fiscal sponsor. Fiscal sponsors may allow the sponsored party to be a "collaborator" through Submittable during the process. However, the eligibility screening and application **MUST** be completed and submitted by the fiscal sponsor, **NOT** the sponsored party.

- ...no Respondent, Bidder, or Proposer shall initiate, engage in, or continue any communication to or with **any City elected official** concerning or touching upon any matter which is the subject of this competitive procurement process.
- From the application deadline through final grant award approval, applicants, fiscal sponsors, board members, employees, consultants, and representatives of applicant organizations shall not communicate with **ARC Members or PRAC members** regarding any pending application
